Project Purpose and Philosophy

The purpose of the Facility is to deliver professional therapeutic services for substance abuse and mental health to adults in an inpatient, non-hospital facility. Our goal is to assist patients in living self-sufficiently in the community.

The Facility is designed to help each client recognize:

- 1. His/her individual bio/psycho/social profile including diagnoses, dependencies, strengths, and symptoms.
- 2. The need for life-long abstinence from substance abuse.
- 3. The need for life management including steps relevant to physical and mental health.
- 4. The importance of continued development of an ongoing recovery program. The Facility recognizes the vital importance of a comprehensive plan for recovery. The Facility will treat and/or refer clients with diagnosed problems and conditions to other services as appropriate to assure each client the best opportunity to thrive.
- 5. The Facility will cooperate and coordinate services with each client's case management and other service providers as applicable.

The philosophy of the Facility states that addiction and mental illness are interrelated human conditions with biological, psychological and social components from which one can recover with treatment, personal commitment and hard work. Even those who cannot fully recover, can learn to better manage their condition with assistance and support. While many experiences can be termed 'therapeutic,' treatment is a professionally applied practice using a consistent theoretical base and evidence-based methods.

A vital component of recovery is development of self-sufficiency. To this end, each client will be encouraged to participate fully in I2-step programs and/or alternative peer-support services, as well as, life-skills training and vocational activities in addition to 'traditional therapy' described above. The Facility believes these activities rehabilitates aspects of life harmed by substance abuse and mental illness.








Gender Identity
